

TASMANIAN BOXING CLUBS BY-LAW

1. Definitions

In this By-Law:

"Tasmanian Boxing Club" means a Tasmanian boxing club, gym or other sporting or recreational organisation which has one or more member or members who is or are registered by Boxing Australia (Tasmania) Incorporated as a boxer or boxers in accordance with clause 18.2 of the Boxing Australia (Tasmania) Incorporated Constitution.

2. Tasmanian Boxing Clubs

2.1 The Secretary shall establish and maintain on behalf of Boxing Australia (Tasmania) Incorporated a Register of Affiliated Tasmanian Boxing Clubs which are affiliated with Boxing Australia (Tasmania) Incorporated.

2.2 The Secretary shall be responsible at all times for ensuring that the Register of Affiliated Tasmanian Boxing Clubs shall contain current information concerning:

- (a) the name of each affiliated Tasmanian Boxing Club;
- (b) the address of each affiliated Tasmanian Boxing Club;

(c) such other information as may from time to time be required by this By-Law or by the Committee.

2.3 Any Tasmanian Boxing Club may apply in writing to the Committee, through the Secretary, to become a Tasmanian Boxing Club affiliated with Boxing Australia (Tasmania) Incorporated from year to year.

2.4 The Committee may, in the exercise of its absolute and unfettered discretion, refuse to affiliate, or to re-affiliate from year to year, any Tasmanian Boxing Club without necessarily providing any reason for such refusal.

2.5 The Committee may determine from time to time the amount of an annual affiliation fee which each Tasmanian Boxing Club must pay to Boxing Australia (Tasmania) Incorporated to secure its affiliation, or the annual renewal of its affiliation, with Boxing Australia (Tasmania) Incorporated.

2.6 No Tasmanian Boxing Club shall be accepted by the Committee for affiliation with Boxing Australia (Tasmania) Incorporated until it has provided the Committee with a notice in writing, duly executed by it, in which it agrees:

(a) to be bound by, and to observe, Boxing Australia Limited's Anti-Doping and Participant Protection Regulations, as amended from time to time;

- (b) that Boxing Australia Limited's Anti-Doping and Participant Protection Regulations, as amended from time to time, may be enforced against it;
- (c) that Boxing Australia Limited may, where appropriate, discipline it in accordance with Boxing Australia Limited's Anti-Doping Regulations, as amended from time to time;
- (d) that Boxing Australia Limited may conduct investigations and, where appropriate, discipline it in accordance with Boxing Australia Limited's Participant Protection Regulations, as amended from time to time; and
- (e) to be bound by and observe all provisions in the Boxing Australia (Tasmania) Limited Constitution, By-Laws, Resolutions and Policies as amended from time to time, which are applicable to it.

2.7 Each Tasmanian Boxing Club affiliated with Boxing Australia (Tasmania) Incorporated shall promptly cause its Constitution, Rules, By-Laws and Policies to conform with the Constitution, By-Laws and Policies of Boxing Australia (Tasmania) Incorporated from time to time.

2.8 Each Tasmanian Boxing Club affiliated with Boxing Australia (Tasmania) Incorporated shall advise Boxing Australia (Tasmania) Incorporated from time to time, and not less than once in each successive six months, of:

- (a) the names and addresses of its members and affiliates, and of changes thereto; and
- (b) the names and addresses of its office bearers, and of

changes thereto.

2.9 Each Tasmanian Boxing Club affiliated with Boxing Australia (Tasmania) Incorporated shall further advise Boxing Australia (Tasmania) Incorporated from time to time of all boxing competitions in which it proposes that it and/or any of its boxers will compete.

2.11 No Tasmanian Boxing Club shall be entitled to participate in any boxing competition or event promoted, organised, controlled or sponsored by Boxing Australia (Tasmania) Incorporated without first being affiliated with Boxing Australia (Tasmania) Incorporated in accordance with this By-Law.
