Club Registration Information Definition of an Amateur Boxing Club

An amateur boxing club is an organization that trains amateur boxers and nominates its boxers for competitions conducted/sanctioned by or affiliated with Boxing Australia (Tasmania) Inc.

Conditions for Registration

- 1. A Club intending to register with Boxing Australia (Tasmania) must satisfy the definition of an amateur boxing club.
- 2. A Club intending to register with Boxing Australia (Tasmania) must only employ (either paid or voluntary) coaches who are registered with Boxing Australia (Tasmania) Inc. Registered boxing Clubs that train children (anyone under the age of 18 years) must only employ (either paid or voluntary) coaches who are registered at level 1 or higher with Boxing Australia (Tasmania) All sections of the Club Registration Form must be completed accurately and with full detail.
- 3. Clubs that coach kickboxing, Muay Thai boxing and other forms of boxing must include details of this coaching in the Details of Coaching section of the Club Registration Form. This information is collected to assist Boxing Australia (Tasmania) monitor and regulate amateur boxing training.
- 4. The correct Registration Fee must be included with the application.
- 5. The Club Registration Form must be signed and dated by:
 - a) The Club's Secretary;
 - b) A witness to the signature of the applicant Club's Secretary.
- 6. The applicant Club's Secretary is advised to read the relevant declarations on the Club Registration Form before signing it. Should the applicant Club's Secretary or Manager be unsure about what is meant in any part of the declaration they are advised to seek clarification from the Secretary Boxing Tasmania before signing the form.
